## **Purpose: New Schools and Boundaries**

- Superintendent's Recommendation to The Charlotte-Mecklenburg Board of Education is final
  - Result of staff work and community engagement
- Public Hearing on Superintendent's Recommendation
  - Feedback received in person and through online feedback form on boundaries, programs, and process
- The Charlotte-Mecklenburg Board of Education will take action at next regular meeting
  - Options include adoption; rejection; and/or modification

#### **Purpose: New Schools and Boundaries**

- New 100 classroom relief high school
  - Funded by 2017 CIP; opens August 2024
  - To relieve overutilization at Ardrey Kell, Myers Park, and South Mecklenburg
- New 54 classroom relief middle school
  - To be funded by 2023 CIP; planned for opening in August 2025
  - To relieve Community House, Jay M. Robinson, and Rea Farms
- Potentially involved schools
  - Other schools and boundaries may see changes to feeder patterns or boundaries given proximity to, and timing of, the new relief schools



# Magnet and Legacy Recommendation


- Language programs to remain at South Mecklenburg
- No changes to the International Baccalaureate (IB) program at Myers Park
  - Current 9th grade students (in 22-23) at Myers Park who are on track for the IB diploma will have the option to remain at Myers Park without transportation, as long as they continue to meet the requirements for the diploma program
    - IB students at Myers Park who no longer meet the diploma program requirements will attend their new home school
  - Myers Park students on track for the IB diploma reassigned to Providence will be guaranteed an IB spot at East Mecklenburg
- New IB program at relief high school
  - MYP (Middle-years program)
  - Feeder schools: Olympic, Palisades, Ardrey Kell, South Meck
    - Providence continues to feed into East Mecklenburg IB

# Magnet and Legacy, continued


- Rising seniors (in 24-25) will automatically finish at their current school
  - With transportation
- Relief high school opens with grades 9-11
  - Rising juniors have the option to stay at their current school
    - Without transportation
    - Following policy <u>O-BUS</u>, regarding bus scheduling and routes, "a pupil residing in one attendance area and attending a school in another attendance area may have transportation to such school from any regular stop within the school attendance area and from the school to the same passenger stop."
    - No sibling guarantee, but may apply for a transfer without transportation
  - Juniors going to their newly assigned school offered transportation
- Rising freshmen (in 23-24) reassigned to South Mecklenburg or Providence high schools may attend 9th grade at their new school
  - With transportation



  - Replaces existing magnet program (Leadership) in 24-25
    - Current magnet students may remain
  - South County K-12 IB pipeline: Huntingtowne Farms ES -Quail Hollow MS - Relief HS
- Rea Farms K-8 transitions from partial to full STEAM magnet K-8 with feed to Phillip O. Berry Academy of Technology
  - 24-25: K-5 becomes full magnet
  - 25-26\*: 6-8 becomes full magnet
    - Current students guaranteed a magnet spot
  - With transportation
  - Will be registered as a magnet student
  - Sibling guarantee remains in place






