Purpose and Intended Outcomes

Purpose:

Create boundaries for the new high school and new middle school in the southern part of the county. New schools alleviate overcrowding and traffic, reduce mobile unit use, are safer, and create enhanced opportunities for participation in sports, band, clubs, etc.

Purpose: New Schools and Boundaries

Reset and Expanded Scope

• New relief high school funded by 2017 bond



- Fall 2024, new 100-classroom high school at 12218 North Community House Road to relieve overcrowding at Ardrey Kell, Myers Park, and South Mecklenburg
- New relief middle school planned for Fall 2025 opening
 - New 54-classroom middle school to relieve overcrowding at Community House, Jay M. Robinson, and Rea Farms
- Potentially impacted schools
 - Additional schools and boundaries are being considered in given the proximity and timing of the new relief high school and middle school

Student Assignment Board Policy

Board Requirement for Student Assignment – Policy JCA (S-ASGP)

• contiguous boundaries

Board's Decision Matrix for School Boundary Decisions – Policy JCA-E2 (S-ASGP/E2)

- home to school distance
- intact feeder patterns
- socioeconomic diversity
- utilization

Board's Additional Factors for Consideration – Policy JCA-E2 (S-ASGP/ED)

- the feasibility of achieving the board's goals through other means, such as establishing partial magnet schools;
- keeping entire neighborhoods assigned to the same school;
- projections for population growth and demographic shifts;
- site limitations or legal restrictions that affect expansion capabilities;
- whether the school has been identified for capital improvements through bond or other funding.



- SES diversity




What We Learned in Phase I
