# Additional Points to Remember Shared by Jennifer Griffith -

- Wrap around care and transportation is not required by NC Pre-K but are awarded extra points if they have it
- o Plans for families with language barriers, challenging behaviors very important
- o how will they plan to transition families into PreK, what is plan to transport etc
- What additional things are they planning to provide to their staff for NC Pre-K
- o how will they ensure that hours are spent planning etc
- how will they plan to meet ratios

- Application Checklist and all documentation is signed by the site owner or not valid.
- 4 and 5 star and temporary license facilities only
- play areas
- Subcommittee will use rubric when scoring the application (possible 92 pts)
  - 8 additional points left for the committee to use for items not included in the application/rubric.
  - Can use 1 pt, 5 pts, 0 additional points. Any combo of additional points or use none.
  - example: additional training, less violations, certifications
- Full committee decides slot allocation
- o Just bc a site is approved doesn't guarantee slot allocation Letter explains this
- Slots should be in areas where need is greatest need
- Can vote to do on site visits for applications set of questions should be asked and the same should be asked at each site
