- III. Results of uniform strawman vote 6:50-7:10p
 - A. As of 12:30pm on May 3, 351 responses to survey
 - B. Commentary revealed that this is a highly polarized topic
 - C. As of 12:30pm on May 3, 58% in favor vs. 70% threshold established on April 27
 - D. Discuss follow-up with parents on results of strawman vote

Strawman survey did not yield % needed to move forward with School Uniform policy. Decision made to move forward with Dress Code Policy and to create FAQ doc for communication purposes. List of questions to include process and timing of the strawman survey and reasons for not moving forward with a School Uniform policy despite a majority of responses indicating interest.

- IV. Next steps for establishing dress code policy 7:10-7:50p
 - A. Dress code is part of the Parent-Student Handbook
 - B. CMS dress code guidelines: The dress and grooming of students shall contribute to the **health and safety** of the individual and promote an **orderly educational environment**. These standards apply to all students, unless a specific exception is made by the school administrator.
 - 1. Rule 4 STUDENT DRESS (Respect/Responsibility) UB: Dress Code Violation: A student will maintain personal attire and grooming standards that promote safety, health, and acceptable standards of social conduct, and are not disruptive to the educational environment. This includes student clothing that materially and substantially disrupts classes or other school activities, including but not limited to gang-related articles of clothing. Please see the dress code at your school.
