### What is a Title I school?

•Title 1 is the largest federally funded educational program. A Title 1 school is a school receiving federal funds for students. The basic principle of Title 1 is that schools with large concentrations of low-income students receive supplemental funds to meet students' educational goals.

### What does it mean to be a Title I School?

- Being a Title 1 school means receiving federal funding (Title 1 dollars) to supplement the school's existing programs. These dollars are used for the following:
  - Identifying students' experiencing academic difficulties and providing timely assistance to help students meet the state's challenging content standards.
  - Purchasing supplemental staff/programs/materials/supplies
  - Conducting parent and family engagement meetings/training/activities
  - Recruiting/Hiring/Retaining Highly-Qualified Teachers
- Being a Title 1 school also means encouraging ongoing parent and family engagement and advocating for parents' rights.

### How will Title 1 funds be used in our school?

Behavior Modification Technician (BMT)

Technology Assistant to assist in the growth of digitally competent global 21<sup>st</sup> century citizens

- Parent Involvement/Activities
- Family Nights (Training for parents for literacy and math
- Professional Development for staff
- Supplies and materials (books and technology)

### What is the 1% set-aside and how are parents involved?

- Any Local Education Agency (LEA) or school district with a Title 1 Allocation exceeding \$500,000 is required by law to set aside 1% of the Title 1 allocation for parent and family engagement.
- Of that 1%, 10% may be reserved at the LEA/district level for system-wide initiatives related to parent and family engagement. The remaining 90% must be allocated to all Title 1 schools ins the district. In CMS, each Title 1 school receives its portion of the 90% to implement school-level parent and family engagement activities and events.
- Title 1 parents have the right to provide input into decisions regarding how this money is spent. This process is completed through the School Improvement Team (SIT)

### Parent and Family Engagement Allocation

- We will be using funding to support Family Nights:
  - 3<sup>rd</sup> grade Read to Achieve Activities
  - Kindergarten Literacy Night
  - Cultural Evening
  - Parent Square
  - The above event are pending SLST approval.

# What is the CMS Parent and Family Engagement Policy?

- This policy addresses how the district or LEA will implement the parent and family engagement requirements of the Every Student Succeeds Act (ESSA). It includes the following:

### How do I request the qualifications of my child's teachers?

- Title 1 parents and families have the right to request the qualifications of their child's teachers
- Request letter known as Right to Know letters are available on our school website. Request for information shall be completed by schools in 30 days of parent request.

## How will I be notified if my child is taught by a teacher who is not Highly-Qualified

- Being Highly Qualified in NC means you have successfully passed the licensure exams required or received alternate licensure in a way set out by NC law
- Our school's present status of Highly-Qualified Teachers
  Nine teachers are completing their residency program, course work, or testing
- Parents are notified if teachers do not meet ESSA's requirements for Highly-Qualified
- Parents may request information on teacher qualifications in writing

### **Complaint Procedures**

- CMS has an Office of the Ombudsman
- The Office of the Ombudsman has a complaint procedure
